Subject : Admission of Students of CBSE affiliated schools in Class XI in Maharashtra State.

Dear Principal,

As you are aware that the scheme of Continuous and Comprehensive Evaluation(CCE) and Grading System was introduced by Central Board of Secondary Education at Secondary Stage in all schools affiliated to it from the academic session 2009-2010. The detailed information about the same has been given to schools from time to time through different circulars which are also available on CBSE website www.cbse.nic.in.

In this system, student's performance has been assessed using conventional numerical marking mode, and the same have been converted into the grades on the basis of the pre-determined marks ranges.

Accordingly, the “**Grade Sheet cum Certificate of Performance**” issued by the Board for Secondary School Examination(Session **2013-2015**) are having only grades as in the past.

However, it has been informed by the Maharashtra Government that they will be using only marks to decide admission in Class XI. Therefore, in order that the students passing out of CBSE affiliated schools and seeking admission in Maharashtra State Institution in Class XI do not suffer, the following has been decided :-

- ❖ The CBSE will give marks of Class X Board Examination 2015 to all its affiliated schools in Maharashtra to enable them to put the same on the students' application forms for admission to colleges in Maharashtra in Class XI.
- ❖ The CBSE will also give soft copies of Class X results (School wise) of schools affiliated to CBSE in Maharashtra to Director, Department of Secondary and Higher Secondary Education, Govt. of Maharashtra(and any other officer deputed by him) so that any verification required by admitting authorities may be done, as the CBSE in this year also will not issue marks.

For the students of CBSE affiliated schools outside Maharashtra State, the following five schools have been identified as Guidance Centres to enable such students to fill up their forms :-
