The Central Board of Secondary Education is the premier national Board under the aegis of MHRD, Govt. of India for conducting Board Examinations for Classes X and XII. It affiliates schools across India and abroad upon fulfillment of various conditions as prescribed in its Affiliation Bye-Laws. At present 20783 schools are affiliated with the Board. The Affiliation Bye-Laws presently in position were first made in the year 1988 and were last modified in the year 2012.

I am glad to inform you that as a step towards introducing major reforms in CBSE Affiliation process, the entire Affiliation Bye-Laws have been revamped. The revamped Affiliation Bye-Laws depict a paradigm shift from the highly complex procedures followed earlier, to a simplified system based on preventing duplication of processes, speedy, transparent and hassle-free procedures and ensuring ease of doing business with CBSE.

In the new Bye-Laws, the requirements for affiliation have clearly been bifurcated into essential conditions for grant of affiliation and post affiliation conditions to be fulfilled before starting academic session. The new Affiliation Bye-Laws also lay thrust on achieving academic excellence through mandatory teacher training. Now the inspection of schools will be outcomes based, more academic and quality oriented. The entire affiliation process will be completely online and integrated with instantaneous communication.

I therefore, solicit cooperation from all stakeholders for studying the revised Affiliation Bye laws and making its implementation hassle-free and transparent. The revised Affiliation Bye-Laws shall come into the force with immediate effect from the date of notification. It is hoped that the Affiliation Bye-Laws 2018 shall prove to be a milestone in the history of major reforms in the Board.
