Examination July, 2014 -Scheme-2

Reg: Modalities and schedule of fee in respect of the processes of Verification of Grades and Obtaining Photocopy of the Evaluated Answer Book(s) for the Secondary School(Class X) for the candidates who appeared under Scheme-2 in IOP held in July, 2014

It is for the information of all the stakeholders that following will be the modalities for applying for Verification of Grades and Obtaining Photocopy of the Evaluated Answer Books(s) for the Secondary School(Class X) Examination, 2014 for the candidates who appeared under Scheme-2.

1. Verification of Grades

- With urgent fee of Rs.300/- per subject within 05 days from the date of declaration of result i.e. w.e.f. 13.08.2014 to 17.08.2014 the applications will be received **only online**.
- With fee of Rs.200/- per subject within 15 days from the date of declaration of result i.e. w.e.f. 13.08.2014 to 27.08.2014. The applications will be received **only online**.
- The requisite fee will have to be deposited through **e-challan** by visiting the identified Bank Branch.
- The result of verification of grades will be uploaded on the NET. However, in case of a mistake a formal letter will also be sent by speed post.
- The Board will not be responsible for any loss or damage or any inconvenience caused to the candidate, consequent to the revision of grade(s) or delay in communication, for reasons beyond control.

2. Application for Obtaining Photocopy of the evaluated answer book

The procedure is as under:

1. applications for obtaining photocopy of the evaluated answer book will be received only online with payment through **gateway/e-challan** alongwith required documents duly scanned. The fee for obtaining photocopy of the evaluated answer book will be Rs.500/- per subject.
2. the application will be received between 21st to 25th day of the declaration of result of IOP examination held in July, 2014 **ONLINE only i.e. 2.09.2014 to 6.09.2014**.
3. candidate applying for photocopy of the evaluated answer book will have to upload an undertaking as per the prescribed format available on the website alongwith photocopy of the admit card.
4. application submitted on behalf of the candidate as also incomplete application will be summarily rejected.
5. fee for obtaining photocopy of the evaluated answer book is Rs.500/- per subject, which will also have to be remitted through **e-challan**, by visiting the identified bank on the NET in case applying from India.
6. it will be the endeavour of the Regional Office of the Board concerned to upload/send photocopy of the evaluated answer book within 15 days from the date of receipt of the application.

7. photocopy of the evaluated answer book would be provided after blocking all information relating to the identity of the Examiner/Evaluator/any other official associated with the examination process as also the mark(s) awarded therein
 8. communication in writing from the candidate would be accepted only for unevaluated portions not later than 07 days from the date of receipt of the copy of the evaluated answer book by the candidate.
 9. decision of the Competent Authority of the Board on the grades awarded shall be final and binding on the candidate.
 10. the candidate shall have to certify that the photocopy of the evaluated answer book shall not be given to any institution or school for display, commercial purpose or to print media by him/her or anyone on his/her behalf.
 11. the photocopy of evaluated answer book shall also not be challenged by any examinee in the court of law or make any claim on this account in any forum.
 12. the Board will not be responsible for any loss or damage or any inconvenience caused to the candidate, consequent upon the delay in communication for reasons beyond control.
3. **In case the applicant is not available in India during the period the application be submitted online and the fee be remitted through DD in favour of Secretary, CBSE drawn at the place of Regional Office alongwith confirmation page, and the same be sent to Regional Office concerned, wherever applicable.**

- (ii) The extension in date is available only in receipt of fee and that too only through E-challan/Demand Draft.
- (iii) It does not mean extension in submitting applications online/offline and/or fee deposit through payment gateway.
- (iv) **The Demand Draft, should be drawn in favour of Secretary, Central Board of Secondary Education payable at the place of the Regional Office concerned. The Demand Draft, alongwith the confirmation page to be generated after online applications has been successfully submitted and should reach the Regional Office concerned within 07 days from the date of submission of the application online.**
