- ✓ WITHIN 21 DAYS FROM THE DATE OF DECLARATION OF RESULT, EITHER ONLINE OR OFFLINE, WITH REQUISITE FEE OF RS.200/- PER SUBJECT

(b) **APPEARED FOR SCHOOL BASED SUMMATIVE ASSESSMENT II IN MARCH -** TO
APPLY TO THE SCHOOL FOR VERIFICATION OF GRADES WITHIN 21 DAYS
FROM THE DATE OF DECLARATION OF RESULT
