Subject: <u>Training Programme for Teacher-regarding</u>

Dear Sir/Madam

Upon ratification by the Governing Body and various committees constituted by the Board and in the light of the Right of Children to Free and Compulsory education introduced by the Government of India, ardent need for the training of teachers was being felt. The Board has modified the Affiliation Bye-laws and included a clause on the training of teachers.

Rule 3.3 h (vi) prescribes that

"Every school should organize at least one week training programme for teachers every year in association with any teachers training institute recognized by the State or Central Government or by any agency identified by the Board".

The above rule has been incorporated as per resolution passed by the Affiliation Committee in its meeting held on 11th June 2009 and subsequently ratified by the Governing Body in its meeting held on 16th June 2009.

In this connection, I am directed to inform you that the Board has identified and empanelled several agencies for the In-service training Programme for the teachers on various aspects of CCE and for the Effective School Management and Leadership programme in order to meet the training requirement of its affiliated schools. These agencies would be conducting these programmes at a very nominal costs. The list of these agencies alongwith the areas of training is available on the CBSE academic website (www.cbseacademic.in).

All the affiliated schools are directed to ensure that their teachers are accordingly trained at the earliest. In case of any problem, they may write to the undersigned.

It is further clarified that the above provisions of Affiliation Bye-Laws have to be adhered by each affiliated school scrupulously otherwise appropriate action will be initiated.
