Financial Market Management in Class IX & X – System of Examination and Practical

Dear Principal,

As you are aware, CBSE in collaboration with National Stock Exchange (NSE) has introduced Financial Market Management (**FMM**) as a vocational course under NSQF (National Skill Qualification Framework) at Level I & Level II for class IX and X from the academic session 2015-16 vide circular no. ACAD/24/2015 dt. 27<sup>th</sup> May 2015 and ACAD/34/2015 dt. 3<sup>rd</sup> July, 2015.

As per the scheme of studies, students will study the subject of "Basics of Money Management" in class IX and "Introduction to Financial Markets" in class X. As FMM course is in collaboration with NSE, a joint certification will be awarded by CBSE and NSE. As such, students will be required to clear a separate online examination from NSE. An examination fee of Rs.500/- per student for class IX as well class X for appearing in the NSE online examination is to be paid directly to NSE.

In order to develop the practical skills, students will also practice for **60 hours** each in class IX and X on various modules of NSE Learn to Trade (**NLT**), a web based market simulation software as per details given below:

SN	Name of NSE - NLT Module	Class
1	Numeric Speed Accelerator (NSA)	IX
2	Function Key Accelerator (FKA)	X

A student who fails to practice for 60 hours on NLT software shall not be allowed to appear for the final practical examination of the above modules in class IX and X. The practical examination will also be conducted on NLT software. The Principal, teachers from schools, CBSE as well as NSE can monitor the progress of any student / school through various management reports generated by NLT. The reports include practice time by students, competency achieved in different module in speed and accuracy, individual progress etc.

All CBSE schools having FMM course may get the **login id and password for NLT software**, for the students who have opted for FMM in class IX and X by paying @Rs.200/- per student per year to NSE. In addition to students, 3 login ids for principal and 2 for teachers will be provided free by NSE.

The schools will consolidate the fee per student of Rs 700/- per student . The details of the students to be enrolled as per Annexure A and the consolidated fee in the form of DD should be drawn in favour of National Stock Exchange of India Limited, Mumbai and sent to the following address.
