



SUBJECT: TRAINING PROGRAMME FOR TEACHERS AS PER RULE 3.3(h) (vi) OF AFFILIATION BYE-LAWS OF THE BOARD

It is widely acknowledged that enhancing teacher quality is a key element in improving school education and promoting students development. Therefore, Systematic in-service training of teachers should be of paramount importance in all schools. This will help in bringing qualitative change in the attitude of teachers. Hence, it is mandated that the schools affiliated with the Board should organize such capacity building training programme for all its teachers at least once every year in association with teachers training institutes recognized by the State or Central Government or the Board itself or the Centres of Excellence of the Board.

1. The **Right to Education Act, 2009 8(i) and 9(j)** stipulates that Appropriate Govt/Local Authority **“provide training facility for teachers”**. The Act further at Section 7(6)(b) stipulates that the **“Central govt should develop and enforce standard for training of teachers”**. In compliance to the above provisions, the CBSE vide amended Rule 3.3(h)(vi) of Affiliation Bye-Laws stipulated that :-

“Every school should organize at least one week training programme for teachers every year in association with any teachers training institute recognized by the State or Central Government or by any agency identified by the Board”.

2. Accordingly, for the purpose of meeting the professional development needs of teachers of the affiliated schools, the Board has set up seven Centres of Excellence for providing training to teachers with jurisdiction over different regions of the Board. The details of these centers and their respective jurisdiction are as under:

It may be noted that the proposal for extension of provisional Affiliation of the school(s) will inter-alia be considered with reference to the school's record of nominating its teachers for training as per the provisions of Affiliation Bye-Laws.
