### OFFICE ORDER



In the absence of a designated official spokesperson, there exists a potential risk of misinformation or misinterpretation of the Board's decisions and initiatives.

To ensure timely, accurate, and authoritative communication, establish a single point of contact for media interactions, and further strengthen transparency and public confidence in the functioning of the Board, the Competent Authority has approved the nomination of **Mrs. Niti Shanker Sharma, Deputy Secretary, Media & PR, CBSE** as the **Official Spokesperson** of the Central Board of Secondary Education with immediate effect.

In this connection, the following directions are hereby issued for compliance:

1. All the Heads of Departments (HoDs) shall furnish daily inputs relating to new circulars, initiatives, decisions, or other significant developments of their respective departments to the Official Spokesperson by 4:00 PM on each working day, under intimation to this office.
2. The Official Spokesperson shall prepare and disseminate appropriate videos/media bytes based on the inputs received and ensure their upload on the official social media platforms of CBSE by 5:00 PM daily, in accordance with the Board's communication protocols.
3. All media-related queries and communications shall, henceforth, be routed through the Official Spokesperson under intimation to this office.
