OFFICE ORDER

Consequent upon the approval of Finance Committee of the Board in its meeting held on 10.12.2015 and further ratified by the Governing body in its meeting held on 18.12.2015, the following amendments have been incorporated in the medical Rules to alleviate the difficulties of Board's regular/retired employees and their dependent family members:-

- 1. Places where employees (regular/retired) and their dependents undergo treatment and CGHS scheme/ CBSE Panel Hospitals do not exist-Reimbursement of medical treatment expenses admissible under rules in non-emergency/ emergency cases may be considered for State approved/ registered Private hospitals/ Govt hospitals limited to CGHS rates prescribed for the place of treatment or CGHS rates of the city nearest to the place where treatment has been obtained or as per actual, whichever is less.
- 2. Places where CGHS rates/ scheme exists and employee (regular/retired)and their dependents undergo treatment but CBSE Panel Hospitals do not exist-Reimbursement of medical treatment expenses admissible under rules in non-emergency/ emergency cases may be considered for CGHS empanelled hospitals/ Govt. Hospitals as per CGHS approved Rate's.
- 3. The condition in intimation to office within 72 hours will not be applicable in both above cases. However, the claim may be submitted to CBSE with detailed original bills, discharge summary (in case of IPD) including breakup for charges on room rent, laboratory investigations, pharmacy, date wise doctor visits, prescriptions slip and diagnostic report's, emergency certificate (if applicable) etc., in duplicate along with a covering letter and checklist form! Essential Certificates. These bills of reimbursement of medical expenses shall be submitted within a time limit prescribed under Medical rules of the Board. Late submission will summarily be rejected. In all cases, the decision of competent authority of the Board would be final.
