The Principal(s)/Head of Institution(s) Schools Affiliated to CBSE.

Madam / Sir,

You are aware that services of the teachers are paramount in the assessment of learning of the students of classes-X and XII. Practical for Class-XII are scheduled from 1st March, 2021 to 11th June, 2021 and evaluation for both Class – X & XII will also start from 7th May, 2021. Quality teachers in sufficient quantity are required to complete both the activities qualitatively and successfully.

Following has come to the notice of the CBSE:-

- 1. that teachers appointed as an external examiner have resigned and thus not available to act as external examiner
- 2. that in the new session i.e. 2021–22, teachers working as PGT, TGT & teaching to Classes XI / XII and IX / X respectively have been assigned the lower Classes. With this availability of teachers has been reduced for practical/evaluation. This will be viewed seriously.
- 3. Names of all teachers working in the Schools have not been provided in OASIS.

To ensure that the names of all the teachers are available in the OASIS, schools should take following action:-

- 1. Schools should update / correct the data of teachers without being failed in OASIS. Link of OASIS is open from 5th April, 2021 to 10th April, 2021.
- 2. Names of all teachers be updated.
- 3. Schools have conducted practical with an examiner not appointed by CBSE.

All the Principals are directed to update teachers' data in the OASIS within schedule. CBSE will compare both the data i.e. before updation and after updation. In case, it is observed that data has not been updated by the school, following action would be initiated:-

- 1. CBSE will take necessary action as per Affiliation Bye-laws & Examination Bye-laws.
- 2. A personal penalty of Rs. 50,000/- will be imposed on the Principal of the School.

CBSE will draw the teachers from each school, based on the number of students, sponsored by the school in Class X & XII.
