## SUBJECT: PERIOD FOR APPEARING IN ADDITIONAL SUBJECT-REG

#### Madam/Sir,

As per Examination Bye-Laws, a candidate who has passed Boards' Examination can apply for additional subject from the list of subjects within 06 years of passing the examination. However, candidate cannot apply for an additional subject involving practical work.

As per approval of the Examination Committee in its meeting held on 15<sup>th</sup> December 2020 and approval of the minutes in the Governing Body meeting of the Board on 23<sup>rd</sup> December, 2020, the period for applying for additional subject(s) has been reduced from 06 years to 02 years only after passing the examination.

This rule will be effective from the 2021 examinations.
