राष्ट्रीय शिक्षा नीति 2020 की छठी वर्षगांठ के दृष्टिगत 27 से 31 जुलाई 2026, एक पाँच दिवसीय ऑनलाइन प्रशिक्षण कार्यक्रम आयोजित किया जा रहा है। यह कार्यक्रम केंद्रीय शैक्षिक प्रौद्योगिकी संस्थान, राष्ट्रीय शैक्षिक अनुसंधान एवं प्रशिक्षण परिषद् द्वारा आयोजित किया जा रहा है। इसका उद्देश्य प्रतिभागियों को सामाजिक एवं आर्थिक रूप से वंचित समूहों (SEDGs) की शैक्षिक आवश्यकताओं तथा समतामूलक एवं समावेशी शिक्षा सुनिश्चित करने हेतु एनईपी 2020 के प्रावधानों की बेहतर समझ प्रदान करना है। कार्यक्रम में प्रारम्भिक बाल्यावस्था देखभाल एवं शिक्षा (ECCE), जेंडर इन्क्लूज़न फंड, विशेष शिक्षा क्षेत्र, समावेशी शिक्षाशास्त्र, प्रौद्योगिकी-सक्षम अधिगम तथा संस्थागत सहयोग तंत्र जैसे प्रमुख विषय सम्मिलित हैं, ताकि समावेशी शैक्षिक प्रथाओं के क्रियान्वयन को सुदृढ़ किया जा सके।

With the view to mark the 6th anniversary of the National Education Policy (NEP) 2020, a 5-Days Online training programme is being organised from 27 to 31 July 2026, this program is being conducted by the Central Institute of Educational Technology, National Council of Educational Research and Training. It seeks to deepen participants' understanding of the educational needs of Socio-Economically Disadvantaged Groups (SEDGs) and the provisions of NEP 2020 aimed at ensuring equitable and inclusive education. The programme will cover key initiatives such as Early Childhood Care and Education (ECCE), the Gender Inclusion Fund, Special Education Zones, inclusive pedagogy, technology-enabled learning, and institutional support mechanisms to facilitate the effective implementation of inclusive educational practices.
