#### Madam/Sir,

This is in continuation of Circular dated 08.12.2021 regarding registration of students of classes IX/XI for academic Session 2021-22. Considering the requests received from the countries situated in Gulf (Middle-East), the schedule for registration of students of studying in these countries has been revised as per given details:-

Registration fee (IX, XI) will not be charged from visually impaired candidates.







#### Illustrations for calculating late fee are as given below:-

The date on which the data is finalized is taken for account for fee calculation

- (a) If students' details are entered and finalized on or before 14.1.2022, the school can pay the fee till 18.1.2022 without late fee. Thereafter late fee shall be applicable.
- (b) If students' details are entered and finalized on 15.1.2022, the school can pay the fee till 19.1.2022 without late fee. Thereafter late fee shall be applicable.
- (c) If students' details are entered and finalized on 16.1.2022, the school can pay the fee till 20.01.2022 without late fee. Thereafter late fee shall be applicable.
- (d) If students' details are entered and finalized on 17.1.2022, the school can pay the fee till 21.01.2022 without late fee. Thereafter late fee shall be applicable.
- (e) If students' details are entered and finalized on 18.1.2022, the school can pay the fee till 22.01.2022 without late fee. Thereafter late fee shall be applicable.
- (f) For Registration with late fees, +4 days from the date of finalization of Registration data will be applicable in the same way as given in (a) to (e) above.

It may be noted that if the data of registration of students is not finalized by 18.01.2022, late fee will be applicable. The time window of +4 days is only available for depositing fee after the FINALIZATION of data. The finalization of data is an activity subsequent to entry/upload of students' registration data.

All other terms and condition given in Circular dated 08.12.2021 will remain the same.
