**Subject: Amendments in Affiliation Bye-Laws-2018 under Chapter 4.- reg**

As per the recommendation of the Affiliation Committee in its meeting held on 21.05.2025 vide Agenda Item XIII, ratified by the Governing Body in its Meeting held on 25.06.2025 vide Agenda Item IV and subsequent approval of the Controlling Authority of the Board, the following amendments in the Affiliation Bye Laws are hereby notified:-

Existing Rule	Amended Rule
<b>Clause No. 4.4.1</b> The school should have a minimum of 20 computers and maintain computer to student ratio of 1:20.	<b>Clause No. 4.4.1</b> The school should have a minimum of 40 computers and maintain computer to student ratio of 1:18.
<b>Clause No. 4.4.3</b> There should be minimum one lab if the school strength of students in the school is upto 800. For every additional (upto) 800 students, one more lab will be required.	<b>Clause No. 4.4.3</b> There should be a minimum one lab if the school strength of students in the school is upto 720. For every additional (upto) 720 students, one more lab will be required.
