**Sub: Implementation of CBSE Counseling Hub & Spoke School Model (Session 2025-26)**

The Central Board of Secondary Education has conceptualized the *CBSE Counseling Hub & Spoke School Model* to strengthen psychosocial support systems in schools by fostering a collaborative network of Hub Schools and Spoke Schools. Anchored in the vision of the National Education Policy (NEP) 2020, this model seeks to:

- Enhance accessibility,
- Build institutional capacity, and
- Promote peer learning in student wellness and counseling.

For the session 2025-26, CBSE has identified Hub Schools along with their corresponding Spoke Schools. The list of these schools is **annexed**.

1. **School Heads/Principals of Hub & Spoke Schools:** To extend leadership and guidance for implementation.
2. **Counselors/Wellness Teachers of Hub & Spoke Schools:** To operationalize the model under the supervision of the School Head/Principal.
3. **Collaboration:** Counselors of Hub Schools shall collaborate with Counselors of Spoke Schools for the joint implementation of prescribed monthly activities.
4. **Reporting Framework:**
  - Spoke Schools shall submit monthly reports to their respective Hub Schools.
  - Hub Schools shall compile and submit a consolidated report by the **5th of every month** through the following Google Form:
