- 2. It was specifically mentioned in the aforesaid advertisement that, before applying to the post(s), the interested candidates must satisfy themselves and ensure that they fulfil essential criteria as per Recruitment Rules and other conditions mentioned in the advertisement.
- 3. The candidates were provisionally allowed to appear in the Computer Based Test (CBT) based on the information submitted by them online, without ascertaining their eligibility for the respective post(s).
- 4. The Board published the list of provisionally shortlisted candidates for further selection process vide Result Notice No: CBSE/Rectt.Cell/14(85)/DR/2020/3391-3490 dated 16.10.2020 based on their performance in the Computer Based Test (CBT). The candidates were directed to present on the specified date of interview alongwith their originals and testimonials. Before interview, the documents of the candidates were verified to establish their eligibility for the post and thereafter, the candidates who were found to be eligible were allowed to appear in the interview.
- 5. During the scrutiny of the documents before interview, the following candidates were found ineligible as they did not fulfil the essential eligibility criteria and/or experience as laid down in the Recruitment Rules for the post(s) applied and other conditions of the advertisement:-


