CORRIGENDUM

The Board has published the final result for the post of Accountant vide Result Notice Result Notice(s)No: CBSE/Rectt.Cell/14(85)/DR/2020/ 3033-3132 dated: 28.09.2020. Further, the Board has utilized both select as well as reserve panels vide Result Notice: CBSE/Rectt.Cell/14(85)/DR/2020/4703 dated: 15.04.2021 and Notice No: CBSE/Rectt.Cell/14(85)/DR/2020/10552 dated: 11.10.2021 and no candidate was found eligible as per prescribed Recruitment Rules for appointment on the post of Accountant.

2. However, at a later stage this office has received of various RTIs/representations from some candidates regarding result declared by the Board, which were forwarded to the recruiting agency (engaged by the Board for providing end to end online recruitment services for recruitment of various categories of posts) for its comments. The recruiting agency, after thorough scrutiny of the contents of RTIs/Representations, has submitted the revised result for the post of Accountant. Accordingly, the result in respect of following candidates has been revised:

Note 1: The documents in respect of candidates mentioned at Sl No. 01 to 04 have already been verified by the Document Verification Committee and the candidates were found either NOT ELIGIBLE by the Document Verification Committee or ABSENT. Now these candidates have been dropped from the select panel as per revised result received from the recruiting agency.

2: Since no candidate from select panel was found eligible as per Recruitment Rules prescribed for appointment on the post of Accountant, the candidates placed in reserve panel (including candidate mentioned at Sl. No. 5) were called for document verification and were found either NOT ELIGIBLE by the Document Verification Committee or ABSENT. Since, candidate at Sl No. 05 remained absent during document verification process, his/her candidature is hereby cancelled.

3: The schedule for document verification in respect of candidate mentioned at Sl No. 6 will be uploaded on the CBSE website shortly.

5. As per advertisement, in cases where more than one candidate secures equal aggregate marks, tie is resolved by applying the measures i.e. Date of Birth, with older candidate placed higher.
6. The horizontal reservation cuts across the vertical reservation (which is called interlocking reservation) and the category who have been provisionally recommended for selection against the PwBD quota have been placed in their appropriate category viz. SC/ST/OBC/EWS/UR depending upon the category to which they belong in the roster meant for reservation SC/ST/OBC and EWS by making necessary adjustment in the same category of quota, as per DoPT/Govt. of India rules.
7. Mere inclusion of the name of the candidate in the list of provisionally eligible candidates in the result notice does not confer any right upon the candidate over the post unless the Board is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
8. The provisional selection of above candidates shall be further subject to genuineness of the documents on the basis of which he/she has claimed to have fulfilled all the eligibility conditions as prescribed in the Recruitment Rules and terms and conditions of advertisement inviting applications and subject to thorough verification of his/her identity with reference to their photographs, signatures/handwriting etc. in the application form, admission certificate etc. The candidature of the candidate is liable to be cancelled by CBSE, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other grounds for disqualifications. The decision of CBSE regarding eligibility of the candidate shall be final and binding on the candidates. The Competent Authority of CBSE shall issue the offer of appointment to the candidates separately after being satisfied about their eligibility as laid down in the recruitment rules and due verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, age and other essential certificates.
9. The schedule for document verification for TALATI AKANKSHA HEMAT will be uploaded on the CBSE website shortly. Candidate is advised to visit CBSE website regularly for latest information. The candidate is advised to download the attestation from the link (<https://www.cbse.gov.in/cbsenew/documents//AttestationForm.pdf>) and bring the duly filled triplicate copies of the same along with the three sets of self-attested photocopies of their documents on the day of document verification.
10. While every care has been taken in preparing the said result, CBSE reserves the right to rectify errors and omissions, if any, detected at any stage.
