Subject: Digital Evaluation of Class XII Answer Books – Mock Evaluation and Monitoring Instructions

Madam/Sir,

You are aware of that Central Board of Secondary Education (CBSE) has decided to introduce On-Screen Marking (OSM) for the evaluation of Class XII answer books beginning with the 2026 examinations. Evaluation of Class X answer books will continue in physical mode as before in 2026. In this regards, a webinar was also organised on 13.02.2026.

As informed during webinar, to ensure readiness before the commencement of evaluation work, the following has been decided :-

1. All teachers after updation of their OASIS data (if any) will be supplied login credentials on their registered email id.
2. Teachers will thereafter login on the Digital Evaluation Platform from their school and change their password with the facility available on the system. Once they are logged-in and changed the password, they will note their log-in credentials for the future use and keep it safely. Evaluator authentication will be done through OASIS ID, School Code and Date of Birth for accessing the OSM Portal for Practice Session.
3. They will also be informed about their successful log-in on the system and some other information about future action.
4. Teachers will obey the instructions given therein for future action mandatorily and do the practice several times to get themselves acquainted with the system to avoid problem on the actual day of start of evaluation.
5. CBSE will monitor their activities of log-in and thereafter practice sessions also. Teachers are allowed to go for practice at unlimited number of times.

It has been decided that this facility will be made available to all from 16.02.2026 onward for about a week's time.

Therefore, all Principals are hereby directed to ensure that teachers teaching classes XI & XII shall compulsorily complete both the activities as enumerated above. The

participation in this preparatory exercise is essential for the smooth and error-free implementation of digital evaluation.

For monitoring purposes, a dedicated dashboard has been made available to schools. It will enable Principals to track:

- Total number of teachers of Classes XI and XII whose details are updated on the OASIS portal
- Number of teachers who have completed the OSM practice
- Number of teachers yet to participate
