Madam/Sir


CBSE Board has launched the **Integrated Payment System (IPS)** to process payments to schools, observers, and external examiners for the Practical Examinations 2026.

The rates of remuneration, conveyance, refreshments, and other related expenses for Practical Examinations have been revised by the Board and are applicable from the Board Examinations 2026. Accordingly, the IPS Practical 2026 portal has been developed incorporating the revised rates for remuneration, conveyance, and refreshments. It is further informed that, as assured on various platforms that IPS portal for various modules will be immediately started on completion of examination related activity, accordingly the IPS Practical 2026 portal is being launched immediately after the completion of the Practical Examinations 2026.

All schools are requested to complete the required data entry and freeze their data so that payments to various functionaries can be released immediately. Please ensure that the bank account details are entered correctly. The Principals must personally review the data before finalizing and freezing it on the IPS portal to avoid any inconvenience at a later stage.

The schedule of IPS Practical 2026 will be as under:

Submission and Freezing of Data by Schools	Releasing of Payment
17 th March 2026 to 31 st March 2026	23 March 2026 onwards
Refreezing in case of failure payments	Releasing of Payment
1 st April 2026 to 15 April 2026	6 th April, 2026 onwards
The portal with reference to practical 2026 payments will be closed on 16th April, 2026
