Subject: Following accuracy while submitting Registration data for class IX/XI 2025-2026 - reg.

Madam/Sir.

CBSE has issued a detailed notification no CBSE/COORD/REGN/2025-26/ dated 11/09/2025 regarding all the pre requisites to fill the Registration data for class IX/XI 2025-2026 along with detailing the importance of correct and timely submission of Registration data by all affiliated schools in case of all of your students.

All school are directed to go through the above-mentioned circular meticulously before filling up of candidates' data as this is the first step towards preparation for Board Examinations 2026-2027. The Staff engaged for filling up of candidates' data should be made aware of all the guidelines, which are laid down in the said circulars to avoid any mistakes. Parents may also be briefed about the importance of correct data and the consequences arising thereby of wrong data submission.

Schools are directed to ensure that data for 100% students studying in Class IX/XI may be filled and no student remains unregistered in these classes for any of the following reasons:

- The student was unwell/ not in station and not attending during the period of Registration of Data.
- 2. The name was mistakenly left/deleted due to any reason
- 3. Any technical failure

If any student is left from registration and request is made in 2026 while submitting LOC for 2027, request will not be accepted for registration and school will not be allowed to sponsor any student(s) for the 2027 examinations.
