It is informed that mere inclusion of the name of the provisionally shortlisted candidates from Reserve Panel in the result notice does not confer any right upon the candidate over the post unless the Board is satisfied after such inquiry as may be required necessary that the candidate is suitable in all respect for appointment to the post.

The provisional selection of above candidates shall be further subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the Recruitment Rules and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to photographs, signatures/handwriting etc. in the application form, admissible certificates etc.

5. The candidature of the candidate is liable to be cancelled by CBSE, in case, candidate is found not fulfilling any eligibility conditions of the Recruitment Rules for the post(s) or for any other grounds for disqualifications.

6. The decision of CBSE regarding eligibility of the candidate shall be final and binding on the candidates. The Competent Authority of Board shall issue the offer of appointment to the candidates separately after being satisfied about their eligibility as laid down in the Recruitment Rules and terms & conditions of detailed advertisement dated 08.03.2024.

7. It is further informed that every care has been taken in preparing the result, the Board reserves the right to rectify errors and omissions, if any detected at any stage.
