

TERMS AND CONDITIONS

- Completion Period: Work shall be completed within 15 days from date of issue of work order.
- 2. Work Scope: Includes dismantling, shifting, loading, unloading, reinstallation, and testing of compactor units as directed by Engineer-in-Charge.
- 3. Damages: Any damage during shifting or reinstallation shall be made good by the contractor at no extra cost.
- 4. Warranty: Smooth functioning of compactors for 6 months after reinstallation shall be ensured by the contractor.
- 5. Approval of Materials: All materials/consumables (if any) must be approved by Engineer-in-Charge before use.
- 6. Penalty: Delay in completion shall attract penalty @ 1% per week, maximum 5% of the total value.
- 7. Safety & Cleanliness: Contractor shall ensure safety of materials and maintain cleanliness of site.
- 8. Payment: To be made after satisfactory completion and certification by Engineer-in-Charge.
- 9. PAN & GST: Valid PAN, GST and bank details must be furnished with quotation.

10. Performance Security:

The successful bidder shall deposit performance security as per CPWD norms, i.e., 3% of the tendered value, in the form of Demand Draft or Bank Guarantee from a scheduled bank, valid up to the completion period plus 60 days.

11. Turnover:

The bidder should have an average annual financial turnover of at least 100% of the estimated cost of work (₹4.29 lakh) during the last three financial years, duly certified by a Chartered Accountant.

12. Experience:

The bidder should have successfully completed similar works during the last three years, ending the last day of the month previous to the one in which tenders are invited, satisfying any of the following conditions:

Three similar works each costing not less than 40% of the estimated cost;

or

Two similar works each costing not less than 60% of the estimated cost;

or

- One similar work costing not less than 80% of the estimated cost.
- 13. CBSE's Rights: CBSE reserves the right to cancel or modify the tender at any stage without assigning reason
