Sub: Amendment/Addition in Affiliation Bye-Laws, 2018 of the Board (Requirement of land area) – regarding

The competent authority of the Board after due consideration has accorded approval for the following amendments/additions in Affiliation Bye-Laws-2018 of the Board.

Clause 3.5 of Affiliation Bye-Laws- 2018

Existing Clause	Amended Clause may now be read as
For the schools located within the limits of Municipal Authority of the cities classified as Class-X (At present Ahmedabad, Bengaluru, Hyderabad and Pune) by the Government of India the minimum land requirement will be 2000 square meters for Secondary School and 3000 (or 4000) square meters for a Senior Secondary School subject to the restriction of optimum enrolment and number of sections given in Appendix-V.	For the schools located within the limits of Municipal Authority of the cities classified as Class-X (At present Greater Mumbai , Ahmedabad, Bengaluru, Hyderabad and Pune) by the Government of India the minimum land requirement will be 2000 square meters for Secondary School and 3000 (or 4000) square meters for a Senior Secondary School subject to the restriction of optimum enrolment and number of sections given in Appendix-V.
