In April 1930, Abdul Ghaffar Khan was arrested, angry crowd demonstrated in the streets of Peshawar, facing armoured cars and police firing. Many were killed. A month later, when Mahatma Gandhi himself was arrested, industrial workers in Sholapur attacked police posts, municipal buildings, law courts and railway stations all structures that symbolized British rule. A frightened government responded with a policy of brutal repression. Peaceful Satyagrahis were attacked, women and children were beaten and about 1,00,000 people were arrested. 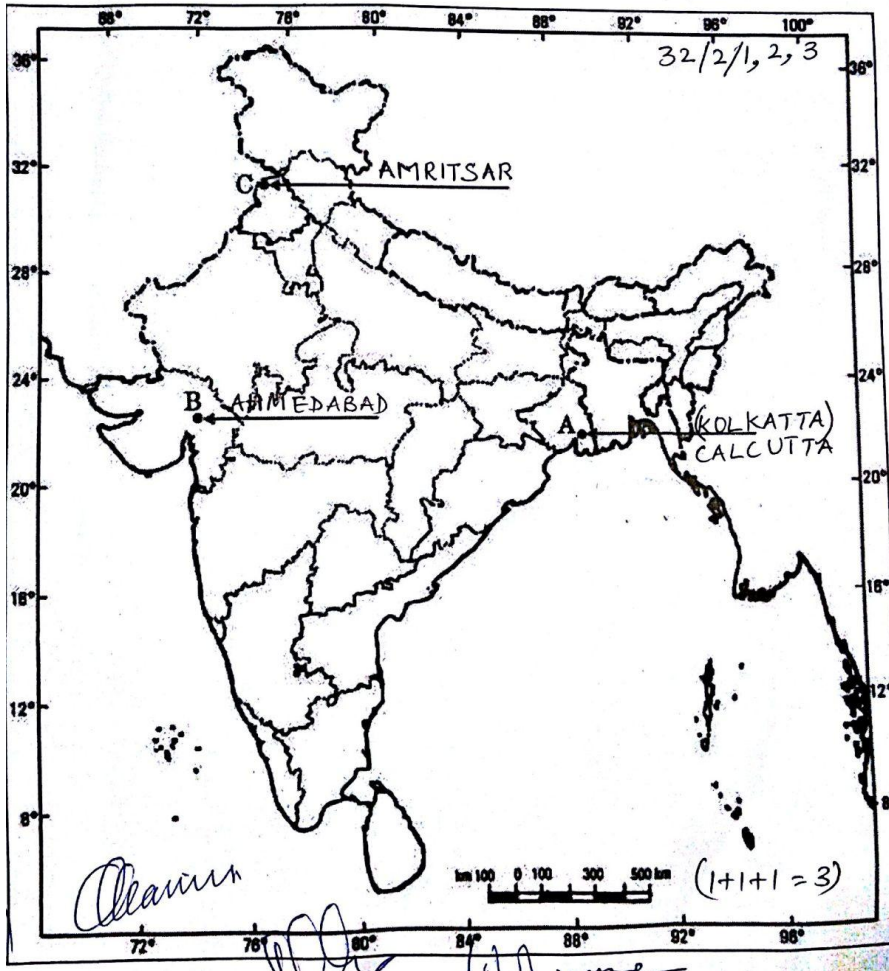

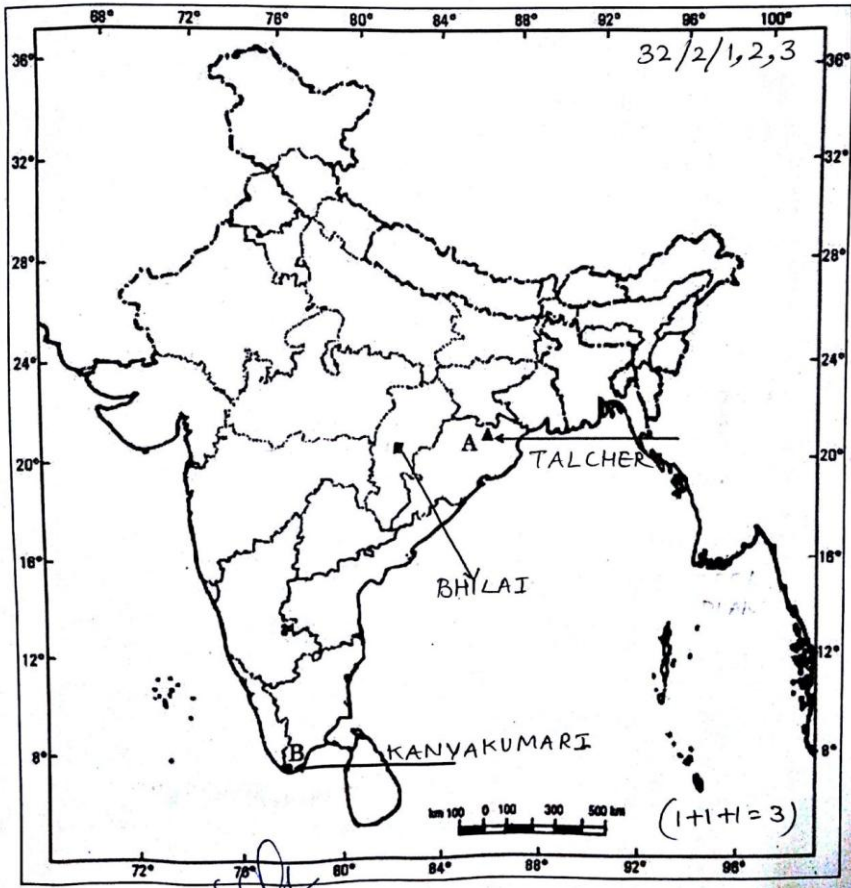
