Consequent upon the decision of the Central Government and subsequent approval accorded by the Competent Authority of the Board, the Central Civil Services (Revised Pay) Rules 2016, the revised pay scale as per the Pay Matrix, as contained in Part-A of the Schedule of has been adopted/implemented in the Board w.e.f. 01.01.2016; as notified on 25.07.2016 by the Ministry of Finance, Department of Expenditure vide G.S.R. 721(E) in CBSE in accordance to the stipulations contained in Department of Expenditure, Ministry of Finance OM No. F.No. 1/1/2016-E.III(A) dated 13.01.2017. (vide OM No. CBSE/JS(A&L)/2017/466-490 dated 13.01.2017)

- 2. Accordingly, all the employees of the Board (posted in Delhi/NCR) were asked to submit their Option Form(s) to the 'Implementation Committee" of their respective office for fixation of pay as per the Pay Matrix as contained in Part-A of the Schedule of the Central Civil Service (Revised Pay) Rules, 2016. The recommendation of the 7<sup>th</sup> CPC for grant of Transport Allowance, House Rent Allowance and discontinuation of Family Planning Allowance has been implemented/adopted in the Board (including Regional Offices/Units/CoEs) w.e.f. 01.07.2017, in pursuance to the Office Memorandum No(s). 21/5/2017-E-II(B), 2/5/2017-E-II(B) and 12(4)/2016-E-III.A dated 07.07.2017 issued by Ministry of Finance, Department of Expenditure, Government of India. (Vide Notification No. CBSE/Personnel-A/7th CPC/2017/602-09 dated 24.07.2017 and vide Notification No. CBSE/Personnel-A/7th CPC/2017/1988-95 dated 13.10.2017)

The recommendation of the 7<sup>th</sup> CPC for grant of Travelling Allowance has been implemented/adopted in the Board (including Regional Offices/Units/CoEs) w.e.f. 01.07.2017 in toto, in pursuance to the Office Memorandum No. 19030/1/2017-E.IV dated 13.07.2017 issued by Ministry of Finance, Department of Expenditure, Government of India.
