Consequent upon the recommendations of Cadre Review Committee, approval of the Finance Committee of the Board vide item No. IX in its meeting held on 25.06.2018 and its ratification by the Governing Body in its meeting held on 28.06.2018 and subsequent approval of the Secretary(SE&L), MHRD, Controlling Authority of the Board, the following amendments has been incorporated in the Engineering Cadre:

- i) There shall be inter se-seniority amongst total 09 technical persons (viz. 01 of Telephone Operator, 01 Electrician, 03 Lift Operator, 01 Plumber, 01 Carpenter, 01 Mason and 01 Wireman) from the date of appointment.
- ii) The Grade Pay of Rs.4200/- & 4600/- has already been approved on personal basis in r/o of technical cadre vide office Order dated 01.10.2014 and some of the technical staffs have already been granted financial upgradation in G.P. of Rs. 4200/- in PB-2 as per 6th CPC. After finalization of inter se-seniority of technical staff, they shall be re-designated as Technical Supervisor in G.P. of Rs. 4200/- of 6th CPC and considered for promotion to the vacant post of Junior Engineer in G.P. of Rs. 4600/- of PB-2 as per 6th CPC after completion of residency period of 04 years from the date of grant of Rs. 4200/- in P.B.-2 of 6th CPC.
