6. If the Applicant does not receive any information or is not satisfied with the reply of CPIO/PIO, he / she may submit 1<sup>st</sup> appeal addressed to the Appellate Authority within 30 days from receipt of the reply of CPIO/PIO.

7. CPIOs and Appellate authorities should ensure that in no case information sought under RTI Act is delayed beyond stipulated period.
