Most of these books have included a dedicated chapter on the topic of 'Water'. Students are taught about the importance of saving water, and ways to conserve it in their daily lives as well as the impact of human activities on the environment, and the need to conserve natural resources like water.
- 2. Affiliation Bye-laws: CBSE Affiliation Bye-law clause 14.26 mandates that schools actively promote environmental conservation on their campuses. This includes implementing rainwater harvesting, waste management practices, energy efficiency measures, campus greening, and using solar energy. Schools are also required to educate students about environmental conservation and cleanliness. To ensure compliance and track progress, schools must include a detailed account of their environmental efforts in their annual report each year.
