- 2. CPIOs and FAAs are not appointed in the Sub-RO as there is no existing strength to appoint the CPIO & FAA.
- 3. The Link Officer would function as in the absence of first officer due to leave /tour/training/transfer etc.
- 4. Sh. Himanshu Gupta, Secretary, CBSE shall be the Nodal Officer.

- 5. Indian Citizens, with email ID and mobile number may submit RTI Application online with prescribed fee for obtaining information from CBSE under RTI Act. For details, website www.rtionline.gov.in may be visited.
- Applicants are advised to ensure that they address their request to respective CPIO as per jurisdiction given above. Affiliation branch has only information in respect of schools affiliated with CBSE / under consideration cases. In respect of schools affiliated with ICSE / State Board applicants are requested to contact the CPIO concerned.
- 7. Applicants can send their RTI applications directly to CPIO or through Nodal Officer alongwith the requisite fee of ₹ 10/- in the form of Demand Draft / Banker's cheque / IPO in name of "Accounts Officer, CBSE" payable at city where office is located.
- 8. If the Applicant does not receive any information or is not satisfied with the reply of CPIO/PIO, he / she may submit 1st appeal addressed to the Appellate Authority within 30 days from receipt of the reply of CPIO/PIO.
- 9. CPIOs and Appellate authorities should ensure that in no case information sought under RTI Act is delayed beyond stipulated period.
- 10. Joint Secretary (A&L) will perform the duties of Nodal Officer in the absence of Sh. Himanshu Gupta, Nodal Officer.
