**Subject:** Empanelment of **Skill Knowledge Providers (SKPs)** to impart various skill based Vocational Courses in the affiliated schools of CBSE - reg.

As you might be aware that the Central Board of Secondary Education (CBSE) is implementing various Skill based Vocational Courses from Level I (i.e., Class IX) to level IV (class XII) under the National Skill Qualification Framework (NSQF).

The skill education envisions imparting the procedural knowledge and skills to the students that will enable students to excel and emerge successful in real life situation.

As a part of this initiative, the Board has decided to implement various Vocational Courses in different sectors at both secondary level and senior secondary level and hence 17 (Seventeen) Skill Knowledge Providers (SKPs) are empanelled to create Skilled Manpower right from the school level. Students studying in the affiliated schools of CBSE have an option to choose Competency Based Skill Courses, along with the general academic subjects, in order to enhance the skills in their chosen field. These Courses also allow them to explore new avenues to face future challenges despite choice based learning.

All the empanelled Skill Knowledge Providers (SKPs) course-wise/ state-wise (may be seen at annex.) spread all over the Country also augment the role of Learning & Development Specialists, which could have a positive impact for the inclusive growth of the students with a strategic-start from the schools.
