SUB: Examination Centre/Facilitation Centre for AIEEE/CTET/AIPMT Exams conducted by the Board.

(MANDATORY COMPLIANCE)

You are aware that CBSE has been conducting various Examinations such as AIEEE, CTET and AIPMT etc. at the National Level under the aegis of MHRD, Govt. of India.

It has been brought to the notice of the CBSE, Headquarter that some of the schools when approached by the Regional Offices for the purpose of fixing examination centre/Facilitation Centre, are refusing to co-operate. This act on the part of affiliated schools is extremely undesirable and amounts to violation of Affiliation Rules. A list of such schools that are refusing to co-operate for smooth conduct of examinations is being made for initiating necessary action against them including disaffiliation.

The Heads of the CBSE Affiliated School, its Manager / Secretary are hereby requested to appreciate the urgency and sensitivity of the matter and extend their best cooperation in smooth conduct of all the examinations conducted by the Board from time to time. The consent form as and when issued by the Regional Offices must be sent in time furnishing necessary details as asked therein.
