 - ✓ WITHIN 05 DAYS FROM THE DATE OF DECLARATION OF RESULT, ONLY ONLINE, WITH REQUISITE FEE OF RS.300/- PER SUBJECT
 - ✓ WITHIN 21 DAYS FROM THE DATE OF DECLARATION OF RESULT, EITHER ONLINE OR OFFLINE, WITH REQUISITE FEE OF RS.200/- PER SUBJECT
- (b) <u>APPEARED FOR SCHOOL BASED SUMMATIVE ASSESSMENT II IN MARCH -</u> TO APPLY TO THE SCHOOL FOR VERIFICATION OF GRADES WITHIN 21 DAYS FROM THE DATE OF DECLARATION OF RESULT
 - II. No revaluation of the answer book or supplementary answer book(s) shall be done.
 - III. The verification will be restricted to checking whether all the answer's have been evaluated and that there has been no mistake in the totalling of marks for each question in that subject and that the marks have been transferred correctly on the title page of the answer book and to the award list and whether the supplementary answer book(s) attached with the answer book mentioned by the candidate are intact.
