

Terms & Conditions

1. The EMD (धरोहर राशि) is Rs. 50,000/- (Rs. Fifty Thousand Only). It should be in the shape of Bank Draft in favour of 'Secretary CBSE' payable at Ajmer. Tenders without EMD shall be summarily rejected.
 2. An undertaking is also to be attached with the tender form stating therein that the Agency has not been debarred in last three years by any Government Organization.
 3. The agency has to supply the specimen/sample of the chair for comparison purpose, if needed by the office. It will be returned to the supplier in due course of time.
 4. 80% payment shall be released after satisfactory completion of the work and within 2 weeks after submission of the Bill. Balance 15% payment and EMD would be released after completion of satisfactory report within 2 months. The 5% amount shall be retained towards defect liability and will be released after expiry of warranty period.
 5. EMD of unsuccessful bidders shall be returned in due course after finalization of this tender.
 6. The Manufacturer must have its dealership in at least two states.
 7. Transportation/Cartage shall be borne by the supplier.
 8. Work should be completed within 15-20 days after issue of the work order.
 9. Installation shall be done as per the requirement/instructions of the Officer in Charge without any extra charges.
 10. Number of Auditorium chairs may vary as per requirement.
 11. Rate should be quoted for specified model with photograph. Brochure may also be enclosed.
 12. The payment will be made through NEFT. Hence, Bank Detail may also be provided.
 13. Warranty: Minimum one year from the date of installation. However, more warranty period will be preferred. During the warranty period, any damage noticed due to sub-standard material/installation shall be replaced/repared by the Agency.
 14. The supplier must assure that the item and services provided under the contract are based on new, unused and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract.
 15. The supplier further warrants that all services/systems supplied under this contract shall have no defect, arising from design, materials or workmanship except when the design and/or material is required by purchasers specifications or from any act or omission of the supplier, that may develop under normal use of the supplied system in the conditions prevailing in the Board.
 16. All Documentary proof are to be attached.
 17. The Competent Authority of the Board has the right to cancel all or part of any tender without assigning any reason thereof.
 18. The decision of the Board in all matter concerning the tender will be final and binding to all. The jurisdiction of all kind of disputes will be Ajmer only.
