

4	Section 4. Performance Penalty Page no. 9 Point no.3	Failure to deliver encrypted password to the central server of the service provider on the day of examination as per stipulated time. Amount of Penalty: Rs. 45000 per centre	As both mode will be there hence penalty will be decided according to which mode is used.
5	Section 4. Performance Penalty Page no.9 Line no.30	Non Submission of audit report within 5 calendar days of stipulated due date for audit.	Audit report should be submitted within one day of the completion of the audit in respect of a centre.
