Terms & Conditions

1. The rates shall be valid for 60 days from the date of opening of bids.
2. The time is the essence of this contract, hence the supply & installation has to be completed within 07 days from the date of work orders.
3. The agency must have e-mail id so that complaints are lodged through e-mail & lodged telephonically as well.
4. The split Ac's must conform to the latest specifications approved by appropriate agency. The guarantee/warranty cards & technical brochures shall be supplied along with the delivery.
5. The consignment is to be supplied in manufacturer's original packing.
6. During the guarantee period, the complaints lodged be attended within 6-8 working hrs but at the most within 24 Hrs.
7. Payment shall be released after 10 days of satisfactory installation & commissioning.
8. In case of defect involving replacement of the compressors, the work has to be completed within 72 hrs.
9. In case, the A.C supplied is troubling again and again, the agency shall be required to replace altogether.
10. In case of delay in supply & installation, a penalty @ 1% per week shall be levied.
11. The Board also reserves the right to bifurcate the supply order & assign the work to two firms.
12. In case of inordinate delay without any valid reason, the Board shall have the right to rescind the work and forfeit the EMD/P.G.
13. In case of any dispute, the Chairman, CBSE shall appoint an Arbitrator whose decision shall be final & binding on the CBSE and the agency.
