- 2. The Completion time would be 20 days.
- 3. In case of delay, a penalty of 1% per week should be deducted. Subjected to a max of 5% of the tender value.
- 4. The measurement shall be done jointly by the Contractor and Engineer-in-charge
- 5. All T & P shall be arranged by the Contractor.
- 6. 5% of the bill shall be deducted as defect liability and shall be released after one year.
- 7. 25% deviation in quantities would be permitted.
- 8. Extra-item if any would be paid on analyzed Market rates but the work must be executed with prior approval of Engineer-in-charge.
- 9. In case of any dispute, the Arbitrator shall be appointed by the Secretary and his decision shall be binding.
- 10. The materials to be used must be got approved from the Engineerin-charge before installation/use.
- 11. Potable water shall only be used at site / work and arranged ownself by the contractor. Nothing extra shall be paid on this account.
- 12. In case of no/slow progress, the Board shall have the right to rescind the contract & get the work executed at the risk & cost of the defaulting agency.
