Terms and Conditions

1. The work shall be executed as per CPWD specifications and as per directions of Engineer-In-Charge.
2. The Completion time would be 20 days.
3. In case of delay, a penalty of 1% per week should be deducted. Subjected to a max of 5% of the tender value.
4. The measurement shall be done jointly by the Contractor and Engineer-in-charge
5. All T & P shall be arranged by the Contractor.
6. 5% of the bill shall be deducted as defect liability and shall be released after one year.
7. 25% deviation in quantities would be permitted.
8. Extra-item if any would be paid on analyzed Market rates but the work must be executed with prior approval of Engineer-in-charge.
9. In case of any dispute, the Arbitrator shall be appointed by the Secretary and his decision shall be binding.
10. The materials to be used must be got approved from the Engineer-in-charge before installation/use.
11. Potable water shall only be used at site / work and arranged ownself by the contractor. Nothing extra shall be paid on this account.
12. In case of no/slow progress, the Board shall have the right to rescind the contract & get the work executed at the risk & cost of the defaulting agency.
