- 1. The work should be executed as per CPWD specifications and as per directions of Engineer-In-Charge.
- 2. The time of Completion of work would be 45 days.
- 3. The Agency should be submit a Performance Guarantee of 5% of tendered value in addition to EMD before start of work.
